Underscore won five national journalism awards from the Native American Journalists Association in 2022 for work completed in 2021 while also winning five awards from the Society of Professional Journalists in 2023 for work completed in 2022.

4b (Code:) (Expenses \$ **14,757** including grants of \$) (Revenue \$)

Underscore was selected for the Google News Initiative's inaugural cohort for its Data-Driven Reporting Project (DDRP), in partnership with Northwestern University. As part of our yearlong DDRP program, we launched and published an award-winning, four-part reporting series called "Sovereign Justice," illuminating the historical context of tribal law in the Pacific Northwest, examining cases where tribes and tribal members have used federal courts to expand their rights under federal law, and exploring the role of tribal courts in exercising the inherent rights of sovereign Indigenous nations.

Underscore launched a pilot program called the Underscore Indigenous Journalism Fellowship, designed to help equip and encourage the next generation of Indigenous journalists while contributing to broader efforts to improve representation in media. We hosted and trained an Indigenous collegiate journalism student from the University of Montana for an immersive 10-week internship, while also fully paying for the student's transportation costs and housing while in Portland, plus a scholarship upon completion. The program is in its second year this summer. ? Note on number of people served: Our work reaches tens of thousands of people both through our own website/dissemination platforms and through republication by a wide range of news outlets across the region and country.
